H. Old Business

Monthly Road Review (Ron)

- Rosebud Lane. Ron spoke to Cameron at Hopkins about grading. Ron to meet with Hopkins for further review.
- Sky Blue Water. The road was missed the last grading in November. Needs to be widened.
- N. Alma Razor. Could use additional gravel. The 25 MPH sign is shot up. Craig will repair damaged culvert.
- Horseshoe Road. Continue grading, the east end is narrow, needs to be widened. It is unclear if the beaver dam, south side of road, about half mile east of Tamarack Rd has been removed. Follow up needed.
- Barnes Spring Road. Culvert project completed.
- S. Alma Razor Rd. The road is narrow on the north end.
- FEMA money was to be used by 12/31. An extension was filed until 10/25. It was discussed and unanimously agreed to complete the spreading of gravel in the spring.
- Monthly North Pine Area Hospital District (NPAHD). Mike provided an update on
 hospital financials. At the last meeting, the question was asked about the equipment the
 district has purchased and how it is known whether it is still in the district and where it goes
 or what happens when it is pulled out of service.
- **Cemetery Update.** The pedestrian gate install is in process. Thank you to Bill Wagner and Jake Walton for brush mowing around the cemetery fence.
- **.gov email domain.** Options are being explored to create emails ending in .gov for the Townboard members.
- Zoning (Shoreland). Per Kelly Schroeder from Pine County, Ogema does not need to
 manage a shoreland ordinance to control VRBO permitting. DNR confirmed that they would
 defer to Ogema for a VRBO within shoreland areas. With the county managing the
 shoreland zoning, they will not approve permits for VRBO for Ogema Township. Ron
 motioned to allow the County to manage shoreland and for Ogema to not manage the
 shoreland ordinance. Anne 2nd. Motion approved.
- **Fire Contract update.** Discussion on the increased fire services contract from Swiss Township. The proposed increase in the 2025 rates will be challenging as the 2025 tax levies were set in March and sent to the County in September. A public hearing would need to be

called to increase the levies for 2025 and would need to be completed by Dec 27th. Charlie will contact Swiss township to understand options and setup a meeting time for the increased fire services.

New Business

- Monthly Claim Sheets provided
- Mille Lacs Cell Tower. The cell tower has already been erected in a different parcel than the
 original permit/variance was approved for. Bob has the new permit and is waiting for final
 signatures. Tentative public hearing date is set for December 9th, pending the final
 application and fee is received.
- MN benefit association. Changing from one provider to another.
- Snow/Ice Contracts to be reviewed/Updated/Signed. (Ron to coordinate)
- **Resolution for accepting donations.** Ron motioned to accept the donation of the clerk desk and chair. Charlie 2nd. Resolution approved.
- Yearly Meeting Dates. The dates were set and approved for 2025. Clerk to post on website
 and Town board.
- Election Update. The general election went smoothly, had two new election judges, no issues.

- **Townhall seating.** Ron motioned to dispose of the bench located at the back of the townhall. Anne 2nd. Motion approved. Mike offered he and Becky would donate new chairs to the townhall. Ron motioned to dispose of half the chairs in the townhall. Anne 2nd. Motion approved.
