## **Ogema Township**

Regular Town Board Meeting September 12<sup>th</sup>, 2019

The Ogema Town Board held their regular monthly meeting at 8:00 p.m. on Thursday, September 12<sup>th</sup>, 2019 at the Ogema Town Hall. The following were present: Charles Kramer, Ronald Meehan, Anne Haas, Sharol Huggett and Robert Sunstrom. Also present were Michael McCullen, Duxbury Fire Chief and Wallace St. John, District 3 Representative from Mille Lacs Band.

Chairman Charles Kramer called the meeting to order. Pledge of Allegiance was recited.

The Agenda was approved and/or corrected on a motion by Ronald Meehan and second by Anne Haas. Motion carried. All voting, yes.

Open Forum / Citizens input — Michael McCullen, Duxbury Fire Chief gave a handout and reported the number of first response calls coming from Ogema Township and that they are looking for a contract and financial help with these calls. His examples were for the years 2016 -2019 to date. 106 total calls. 28 from Ogema and 78 from Lake Lena Reservation. Wallace St. John overheard this conversation. On a separate subject, Wallace St. John asked town board about renovation to driveway approach on Alma Razor Rd. to Crossroads Convenience store and if there could be a joint effort towards resolving the problem with depth of ditches and water flow through existing culvert pipes. He said that he has the funding for this project now and road could get asphalted from Hwy. 48 going south of first driveway.

Clerk's report was approved and/or corrected on a motion made by Ronald Meehan and second by Anne Haas. Motion carried. All voting, yes. Clerk to file.

The Treasurer's report was approved and/or corrected on a motion made by Ronald Meehan and second by Anne Haas showing a balance of \$45,175.07 in Checking as of September 5<sup>th</sup>, 2019, a balance of \$6,038.16 in Cemetery CD and a balance of \$5.00 in Savings. Motion carried. All voting, yes. Motion to pay the bills was approved by Ronald Meehan and second by Anne Haas. Motion carried. All voting, yes. There were 8 claims paid for the total amount of \$5,048.72 and payroll of \$1,396.15.

- Clerk prepared 2019 Tax Levy Statement to send to County Auditor's office. 5.
- Clerk asked for input with board about the continuation of the grant application with USDA. 6.
- Clerk mentioned the new MATIT insurance quote for expiring policy.
- 8. Board discussed ditch mowing problems with getting vendor to sign off on a service contract agreement and fees charged. Clerk to contact again.
- On a motion made by Charles Kramer and second by Ronald Meehan, Township to purchase 200 gallons of propane on a Pre-buy program with Federated Co-op for town hall. Motion carried. All voting, yes.
- 10. On a motion made by Charles Kramer and second by Ronald Meehan, the 2020 Town Board and Board of Audit meeting will be on February 6th rather than the 13th. Motion carried. All voting, yes.
- 11. Fall harvest pot-luck dinner at town hall on October 13<sup>th</sup>, 2019. All residents welcome.

- 13. Any other new business.
- 14. Clerk showed miscellaneous mailings.
